# OFFICIAL RULES

#### (GOOD THROUGH THE FINAL DRAWING, SPRING 2014)

**1. OBJECTIVE:** Help the Eastern Oregon Mining Association (EOMA)<sup>1</sup> and the Waldo Mining District (WMD) protect your RIGHTS TO MINE as granted by the U.S. Congress in the 1872 Mining Law (as amended) against a constant and continued attack by government agencies run amuck, and by the "so called" environmentalist organizations whose publicly stated goal is the eventual destruction and prohibition of all mining . . . followed by our American way of life!

All proceeds from this series of drawings will be used solely to help fund the EOMA/WMD on-going litigation efforts in connection with the Oregon Dept. of Environmental Quality's (DEQ) "*In-Stream Mining General NPDES Permit 700PM*" issued in July of 2010; and to protect mining in Oregon.

**2. THE DRAWINGS:** EOMA/WMD will be holding at least two *Preliminary Drawings* throughout 2013 leading up to the *Final Drawing* for the "1/2 Lb. of Gold" which will be held at the close of the 2014 Gold Prospector's of America (GPAA) Gold Show at the State Fair Grounds in Salem, Oregon, in the spring of 2014 (exact date to be determined). All entries (including winning coupons) in the Preliminary Drawing(s) will be eligible to win the 1/2 Lb. of Gold.

**1<sup>st</sup> PRELIMINARY DRAWING:** The First Preliminary Drawing will be held on Saturday, March 30, 2013; at the GPAA Gold Show in Salem, Oregon (*need not be present to win*).

**2<sup>nd</sup> PRELIMINARY DRAWING:** July 21, 2013, at the Miner's Jubilee at "*Geiser Pollman Park*" in Baker City, Oregon (*need not be present to win*).

**FINAL DRAWING:** The Final Drawing for the 1/2 POUND OF GOLD will be held at the spring 2014 GPAA Gold Show in Salem, Oregon<sup>2</sup> (*need not be present to win*).

**3. **OFFICIAL COUPON NOT REQUIRED:** Entries can be made using an Official Coupon (fill out the backside) or; by using a plain piece of paper with your *CLEARLY PRINTED*<sup>3</sup> name, address,  $age^4$ , (phone number, and email address<sup>5</sup>). State the total number of entries you are making, and along with a check or money order (made out to EOMA) to cover Entry Fees (see Item #4 below). Please mail to:

Upon arrival, your entries will be transferred to the matching number of Official Coupons by dedicated EOMA/WMD staff and placed in the drum.

Entries may also be dropped off at the Armadillo Mining Shop (Grants Pass, OR), or at other participating businesses (see Item #8 for Drawing Deadlines).

<u>Anyone desiring a receipt for your Entry/s</u> <u>MUST</u> <u>include a Self Addressed Stamped Envelope.</u>

(NOTE: Using and affixing mailing labels on the back of the Entry Coupon is allowed, provided such labels are securely attached to the coupon (taping them on is OK), and that such labels include Name, Address, and other required information. (Note: If such a mailing label falls off of your coupon that coupon will be disqualified).)

Entries can also be made at the GPAA Gold Shows and at the Miner's Jubilee up until the time of the Drawings.

**4. ENTRY FEE:** \$5.00 per Entry, or multiples of Six (6) Entries for \$25.00 (must be made at the same time), or any combination thereof. There is no limit to the number of Entries an individual can make, or on how often they enter.

#### Please make Checks or Money Orders out to EOMA.

**5. ENTRY FEE REDEMPTION OFFER:** Each "*Official Entry Coupon*" comes with a detachable "stub" which can be redeemed for its full value (\$5.00 off) the purchase price of a EOMA Silver Medallion<sup>6</sup>.

EOMA Silver Medallions may be purchased from EOMA through the mail from EOMA. To redeem the \$5.00 Entry Fee, simply send your stub good for \$5.00 off the purchase price, along with the balance (plus shipping & insurance) to EOMA Medallions, P.O. Box 932, Baker City, OR 97814. Only one (1) \$5.00 off "stub" may be used at a time for the purchase of one (1) EOMA Silver Medallion. Orders must be post-marked no later than May 31, 2014. \$5.00 rebate offer expires June 1, 2014.

For those who are not using an Official Entry Coupon but would like to take advantage of the \$5.00 off the purchase price of a EOMA Silver Medallion, please include a SASE with your entries, and the appropriate number of "\$5.00 Off" coupons will be sent to you.

**6. WHO CAN ENTER:** Any citizen or legal immigrant of the United States of America over the age of 18 years (at the time of Entry) is eligible to enter.

**7. WHO CAN WIN:** Anyone that qualifies (see Item #'s 3, 4 & 6 above) and has legibly printed on the entry coupon (or supplied by letter) their name, age, and at least one (1) of the following: Mailing Address, Phone Number, and/or Email Address) may win, with the exception of the individual drawing any particular coupon may not draw their own coupon, or the coupon of an immediate family member (see #10 below).

Illegible or otherwise questionable coupons (see #3 above) will be examined by a panel of at least four (4) judges. **2<sup>ND</sup> PRELIMINARY DRAWING:** All mail-in entries for the July 21, 2013  $2^{nd}$  Preliminary Drawing must be received by the close of business (4:30 pm) in the EOMA P.O. Box at the Baker City (OR) Post Office no later than <u>Friday</u>, July 19, 2013.

Entries at the Armadillo Mining Shop (Grants Pass, OR) or at other participating businesses must be dropped off by the close of business (5:00 pm) on Wednesday, July 17, 2013.

LAST MINUTE ENTRIES will be accepted at the Miner's Jubilee at "*Geiser Pollman Park*" in Baker City (OR) July 18-21 up until the drawing Sunday afternoon (July 21, 2013).

**FINAL DRAWING for the 1/2 POUND OF GOLD:** is scheduled to be held at the close of the spring 2014 GPAA Gold Show in Salem, Oregon.<sup>7</sup> Deadline for entry and exact date of the Final Drawing will be announced as soon as possible.

LAST MINUTE ENTRIES will be accepted at the 2014 GPAA Gold Show in Salem, Oregon up until the drawing.

1<sup>st</sup> **PRELIMINARY DRAWING:** Will be held at the Gold Prospector's of America (GPAA) Gold Show at the Oregon State Fairgrounds in Salem, OR. on Saturday, March 30, 2013.

**2ND PRELIMINARY DRAWING:** Will be held at the EOMA booth at the Miner's Jubilee in "Geiser Pollman Park" in Baker City, (OR) on July 21, 2013.

FINAL DRAWING: Will be held at the Gold Prospector's of America (GPAA) Gold Show at the Oregon State Fairgrounds in Salem, OR. in the spring of 2014. Date to be announced.

# **12. WINNERS WILL BE DETERMINED:** By random drawing from all

- B. If the winner provided an email address, EOMA/WMD will notify the winner within 7 days of the drawing.
- C. In the event that the winner(s) is not present at the drawing and has not provided a phone number or email address, or has not responded to either, EOMA/WMD shall make at least one (1) attempt per week for at least three (3) weeks to contact the winner/s via U.S. Mail based on the contact information provided with the entry. The winner/s shall be given at least three (3) additional weeks to respond and claim their prize by contacting EOMA/WMD. All unclaimed prizes shall become the property of EOMA/WMD (see #16 below).
